1 I, DOROTHY KASIAN, declare as follows:

2 1. I submit this declaration in support of final approval of the settlement of this action for
3 \$6,050,000 (the "Settlement"). I also submit this declaration in support of my request for payment of
4 \$2,500 for time spent in carrying out my responsibilities to the Settlement Class. I have personal
5 knowledge of the statements herein, and if called as a witness, could competently testify thereto. This
6 firm is additional counsel of record for plaintiffs Brent T. Robinson and Dorothy Kasian.

7 2. I made the decision to become involved in this action as a named plaintiff and to seek
8 appointment as co-lead plaintiff. I understood my responsibility to serve the best interests of the
9 Settlement Class and I believe that I have fulfilled that obligation.

10 3. I actively and meaningfully participated in the case by consulting with my attorneys
11 through numerous e-mails, letters, telephone calls and in person meetings, and I was kept fully informed
12 of the status of the case. I also reviewed documents filed by my attorneys and orders entered by the
13 Court. I assisted counsel in responding to discovery requests, including reviewing interrogatories and
14 requests for documents and producing documents and submitting other information that was requested.
15 I also prepared for and sat for a deposition. Finally, throughout the case, I consulted with counsel and
16 provided input regarding litigation and settlement strategy and consulted with counsel regarding
17 settlement negotiations that resulted in the Settlement.

18 4. I authorized my attorneys to settle this action for \$6,050,000 million. In giving my
19 consent, I weighed the ample benefits to the Settlement Class against the significant risks and
20 uncertainties of continuing to litigate the case and my attorneys and I discussed those issues at length.
21 In short, I believe that the Settlement provides a highly good recovery and is in the best interest of the
22 Settlement Class.

23 5. It is my understanding that the Court may make an award for my efforts in serving as a
24 named plaintiff in this litigation and ensuring that the Settlement Class was adequately represented. I
25 am requesting the amount of \$2,500 in collection with my role as co-lead plaintiff. This request is
26 based on the estimate that I spent more than 50 hours on the litigation related activities described above.
